The event also emphasizes the importance of cross-sector collaboration with education, healthcare, the economy and culture in achieving sustainable development.

It will also address pressing Arab issues in the age of AI, such as the digital divide, algorithmic biases and the ability to contribute to open science. Participants will collaborate to develop innovative solutions that boost digital inclusivity and sustainability, while bolstering local, regional and international partnerships to achieve shared goals.
